## WEST CHESTER MUSIC ACADEMY POLICIES AND PROCEDURES

TUITION  1. All recurring payments are processed by pre-authorized credit cards on the 24th of the month that pays for the upcoming month's lessons. Tuition is never prorated for missed lessons. Tuition does not include any retail teaching materials such as books or instruments. (I/We) do hereby authorize the Classical Guitar Academy, LLC, to initiate recurring (debit or credit) entries to (my/our) (Credit Card Account) as indicated and named below as the depository financial institutions
CANCELLATIONS AND MAKEUPS  2. For any lessons missed by a teacher, the Academy will attempt to provide a substitute teacher. If a substitute teacher is unavailable, a private makeup lesson with the teacher will be scheduled promptly. One make-up will be available each month. A make-up must be completed within 30 days of the absence, after which the make-up will be forfeited. Students must notify their teacher of an absence no later than 8pm the day before their lesson. A make-up lesson will be scheduled on a date convenient for both the student and the teacher. A student absence without sufficient notice may not be made-up. No-shows and same-day cancellations are not eligible for make-ups. Lessons cannot be discontinued in the middle of a billing cycle. A teacher absence or inclement weather cancellation will be made-up
DISCONTINUING LESSONS  3. To suspend or discontinue lessons and payments, your teacher needs to be notified before the bill date (24th day of the month). We do not prorate tuition for the last month's lessons. Students will be responsible for their last month's tuition whether or not they attend lessons
AVERAGE OF FOUR LESSONS PER MONTH 4. Monthly tuition is based on the average of 4 lessons per month. We operate on a 48-week year. During the months that you have 5 lessons, we do not charge you more. During the months that you have 3 lessons, we do not charge you less. The tuition is the SAME each month. This makes everyone's accounting easier
SUMMER VACATION  5. The WCMA operates year round and does not close for the summer. Taking lessons year round without a hiatus of instruction is imperative for your child's musical development. We strongly encourage families to work around vacations so that no musical progress is lost
CARE OF STUDENTS  6. The school is not responsible for providing before or after care for students. Parents with children under the age of eight must remain in the lobby during the classes. Students are not to be left at the

Academy for excessive time periods before or after their lessons. \_\_\_\_\_
